Season Pass Terms & Conditions

- SEASON PASS USAGE May only be used by Passholder. Transfer, or the attempt to transfer will result in revocation of the pass without refund, and is punishable under MA THEFT OF SERVICES LAW. Your season pass must be presented to any authorized Blandford Ski Area LLC representative upon request. It must be displayed on your outer garment at all times and be easily visible to ticket checkers.
- LOST Report season pass loss to Main Office immediately. \$50 fee will be charged for season pass replacement.
- FORGOTTEN Season Pass. A full price lift ticket must be purchased.
- AGE DEFINED AS PERSON'S AGE AT TIME OF PURCHASE.
- REFUND POLICY There are no refunds on any products for any reason.
- EXPIRATION Season Passes expire on the last day of the season or April 10, whichever comes first.
