It must be displayed on your outer garment at all times and be easily visible to ticket checkers.
- LOST Report season pass loss to Main Office immediately. \$50 fee will be charged for season pass replacement.
- FORGOTTEN Season Pass - A full price lift ticket must be purchased. _____ (initial)**
- AGE IS DEFINED AS PERSON'S AGE AT THE TIME OF PURCHASE.
- REFUND POLICY - There are no refunds, transfers or deferrals on any products for any reason. _____ (initial)**
